Reward offered in response to theft of fire hydrants, other metal equipment

RIVERSIDE, CA – July 1, 2011 – More than 60 fire hydrants, some which are super hydrants each costing more than \$1,000, as well as manhole covers and backflow devices, have been stolen just within the past several months in Eastern and Western municipal water districts' service areas. To help stop this crime, Western and Eastern have agreed to a \$500 reward to anyone for information that leads to the arrest and conviction of individuals for vandalism or theft of fire hydrants and other metal facilities. The \$500 rewards would be funded by the water agency in which the crime occurred. Water agency staff regularly provides information to scrap metal dealers, including recyclers and the Law Enforcement Joint Task Force, about water agency equipment and facility thefts.

The districts advise anyone who sees suspicious activity around a fire hydrant or other related facilities to call their local law enforcement, or 911.

Theft of fire hydrants and manhole covers, criminally punishable actions, not only endanger communities, it hampers firefighters in not being able to respond quickly to emergencies. It also presents risks to drivers.

Western and Eastern are working closely to increase scrutiny of their water systems, while cooperating with local law enforcement and other neighboring water agencies, many of which are experiencing similar thefts.

The districts are asking customers and residents to join us in keeping an eye on our neighborhoods to help prevent this type of costly and destructive behavior. Please report any suspicious activity to local law enforcement by calling 911. If vandalism has already occurred to facilities, please contact the water agencies directly.
